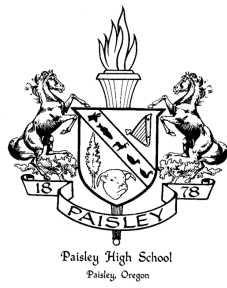




## Invites applications for the position of INTERIM SUPERINTENDENT

**The School District**



**Paisley School District** is a one-school K-12 charter school with a distance learning program and a 2024-25 general operating fund of \$6.99 million. Paisley currently serves approximately 240 students with 160 in the distance learning program, but enrollment is expected to grow to 500 in 2025-26. For 2025-26, Paisley is projected to employ a staff of 12 licensed employees, 14 classified employees, 3 confidential employees, and 2 administrators. Paisley is accredited by Cognia and boasts an 8:1 student teacher ratio in its brick-and-mortar school, which includes a dormitory that hosts eight foreign exchange students.
